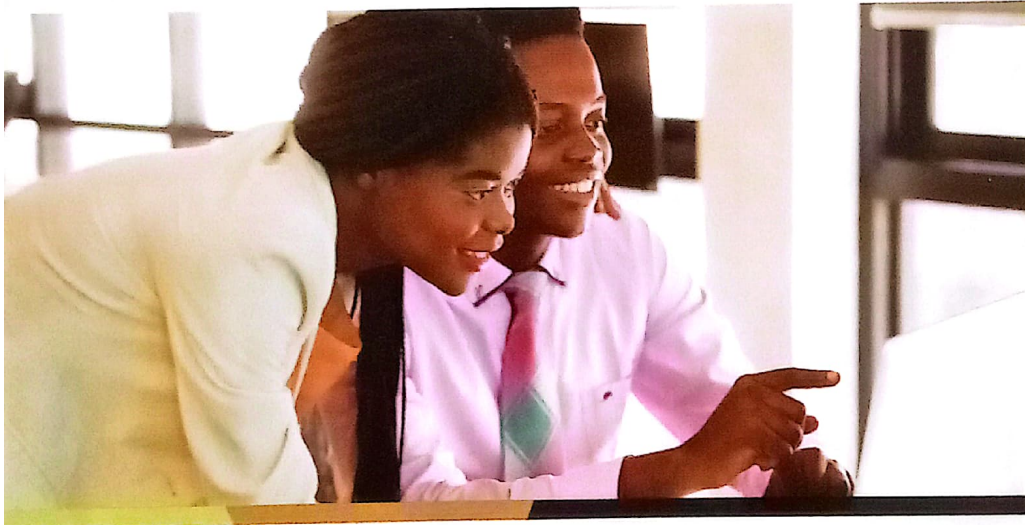

Bid Bonds

A bid bond or tender security is a requirement during the tendering process and is presented to the procuring entity as a guarantee of commitment by the bidding entity to the procurement process. Recolte in partnership with reputable, recognized and authorized financial institutions and insurance companies, facilitates the issuance of bid bonds or tender securities to its clients under flexible terms.

Performance Bonds

Upon winning a contract/Tender, you might be required to issue a performance bond. This gives comfort that the contractor will be able to execute the job. A performance bond ensures payment of a sum (not exceeding a stated maximum) of money in case the contractor fails in full performance of the contract. We issue performance bonds with minimal cash cover. We also charge commissions at very competitive rates.

Advance Payment Guarantees

An advance payment guarantee secures refund of advance payments against default by the supplier or the contractor. An advance payment guarantee is an on-demand bond, where the bondsman is bound to pay the amount of money set out in the bond immediately on demand, without having to meet any preconditions in the contract. An Advance payment guarantee expires when the contract is fulfilled and is commonly used in construction projects.

Contract Finance
